



On December 16, 2022, the PREDOCS UB call was issued in which Predoctoral contracts were called for the 2023/2024 academic year.

It has been detected that the writing of the requirement established at the point 4.1. 1.a excludes those people who have the requirements for access and admission to the PHD program but who have not yet applied for admission or have not enrolled.

Given the circumstances,

IT HAS BEEN RESOLVED TO:

1st. Correct the requirement set out at the point 4.1. 1.a. with the following meaning: Where it says:

- a) To be enrolled full-time in one of the PHD programs of the University of Barcelona. Applications will also be accepted in the following cases: 1) Being admitted in a PHD program; 2) To be studying, the 2022/2023 academic year, the master's degree that gives access to the doctorate in the 2023-2024 academic year. In both cases, it will be an essential condition to be enrolled in a PHD program at the time of signing the contract. If the enrolment could not be possible due to attributable causes to the PHD student (such as not having finished the master degree on time), an extension of the date of start of the contract won't be possible.

It is amended by:

- a) To be enrolled full-time in one of the PHD programs of the University of Barcelona. Applications will also be accepted in the following cases: 1) Being admitted in a PHD program; 2) to be in possession of one of the university degrees that give access to doctoral studies obtained after the 1st of January 2019; 3) Applications will also be accepted in the following cases: 1) Being admitted in a PHD program; 2) To be studying, the 2022/2023 academic year, the master's degree that gives access to the doctorate in the 2023-2024 academic year. In all three cases, it will be an essential condition to be enrolled in a PHD program at the time of signing the contract. If the enrolment could not be possible due to attributable causes to the PHD student (such as not having finished the master degree on time), an extension of the date of start of the contract won't be possible.

2nd. That this resolution be communicated to the Head of Scholarships and Students Grants and published on the website: [APIF- Predoctoral Grants - UB](#) and in the Seu Electrònica de la UB.

Against this resolution, which exhausts the administrative way, regardless of its immediate enforceability, the legitimate interested parties can file an administrative appeal before the Contentious-Administrative Court of Barcelona, in accordance with art. 8 of Law 29/1998, of July 13, regulating the contentious-administrative jurisdiction. The appeal may be lodged within two months, counting from the day following the notification of the decision, as established in article 46 of the aforementioned Law.

However, legitimate interested parties may, optionally, file an appeal for reversal within a period of one month, counting from the day following the notification of this resolution, in accordance with article 123 and following of the Law 39/2015, of October 1, on the Common Administrative Procedure of Public Administrations. If this is filed, the legitimate interested parties may not file the contentious-administrative appeal until it is expressly resolved or the presumed dismissal of the appeal for reversal has occurred.

Otherwise, the legitimate interested parties may file any other remedy they deem appropriate in defense of their rights.
