#### Art, Symbolism and Power in Moche Society, North Coast of Peru

The Moche (2nd-8th centuries A.D.) were one of the most powerful kingdoms of their time on the North Coast of Peru, as were the Nasca in Ica south of Lima and the Tiahuanaco in the altiplano between Peru and Bolivia. Their achievements in their various cultural manifestations are compared with the grandeur of the Maya in Central America. They extended over a territory of 600 kilometers, from Piura in the north to Huarmey in the south. Moche art and symbolism reflect high development in knowledge of the laws of nature that permitted them to recreate it for magical-religious uses. Moche works of art in temple murals, in goldwork, in textiles, in ceramics, etc. express, without doubt, an extraordinary artistic quality that was enjoyed by the powerful Moche lords and their gods.

## ICDHS Meetings:

Searching for a wide-ranging and renovated view of design and design history

The Design History and Design Studies conferences, started with a first meeting that took place in Barcelona in 1999. In the beginning, there was the urge to find a new perspective for design history, theory (and, why not, also for design practice), one that would highlight the differences and include the mapping (not only geographic) of what was disregarded by current history.

Another intention of this first meeting was to provide an international forum for design theoreticians, which would allow them to overcome isolation within professional fields. Later meetings, with similar goals, where held in Havana (2000), Istanbul (2002), Guadalajara (2004), Helsinki (2006), Osaka (2008) and Belgium in 2010. These conferences implied the growth and opening up of the initial intentions. A further achievement of these events is their world wide breadth, once participation has broadened and diversified, growing to include representatives from all continents.

This roundtable intends to summarize and evaluate what has been done so far. This task is essential, considering that ten years have passed.

The organizers of each meeting will provide a brief theoretical and practical view of past conferences, aiming for an appreciation of the theoretical ground covered, and to the indication of directions for future conferences.
