# DOCUMENTS TO BE SUBMITTED WITH THE ACCESS APPLICATION:

- 1. Spanish identity document, passport or EU identity document.
- Original and copy or certified copy\* of the bachelor's degree certificate or equivalent.
- Original and copy or certified copy\* of the transcript of bachelor's degree studies completed.
- 4. Proof of payment of the access fee (the applicant must pay the fee at the Secretary's Office for Students and Teaching Staff of the centre in which they submit the application). Note: Applications will not be processed without such proof of payment.

For degree courses not adapted to the European Higher Education Area (degrees issued before the Bologna process), applicants must also submit:

5. Original and copy or certified copy\* of the document issued by the ministry of education or equivalent authority in the country where the student completed the degree, accrediting that this degree qualification entitles the student to enter a postgraduate study programme.

## **IMPORTANT:**

Students in possession of academic documents issued outside Spain that are required by the UB for administrative purposes must ensure that they have original and official copies issued, in accordance with the legislations in the country of issue. In most cases, these documents must be **translated** and **legalized**.
