1. Permission is granted to view and use the M&Ms Dataset without charge for research purposes only. Its sale is prohibited. Any non-academic research use need to be evaluated case by case by M&Ms organizers. If you intend to use this dataset for any non-academic research use, you need to communicate it describing the intended use and receive approval by the M&Ms organizers.
2. In agreement with the mission of the M&Ms to promote the publication of scientific knowledge as open data, any computational model or algorithm that have used the M&Ms Dataset and is publicly referenced (e.g. in a publication etc..) is suggested to be shared including the code and model weights and must give appropriate credit by citing the M&Ms article but not in any way that suggests that the M&Ms organizers endorses you or your use.
3. Other than the rights granted herein, the M&Ms organizers retain all rights, title, and interest in the M&Ms Dataset.
4. You may make a verbatim copy of the M&Ms Dataset for personal, research use as permitted in this Research Use Agreement. If another user within your organization wishes to use the M&Ms Dataset, they must comply with all the terms of this Research Use Agreement.
5. YOU MAY NOT DISTRIBUTE, PUBLISH, OR REPRODUCE A COPY of any portion or all of the M&Ms Dataset to others without specific prior written permission from M&Ms organizers.
6. You must not modify, reverse engineer, decompile, or create derivative works from the M&Ms Dataset with the exception of works in agreement with the clause number 2. You must not remove or alter any copyright or other proprietary notices in the M&Ms Dataset.
7. The M&Ms Dataset has not been reviewed or approved by the Food and Drug Administration or the European Medicines Agency, and is for Research Use Only. In no event shall data or images generated through the use of the M&Ms Dataset be used or relied upon in the diagnosis or provision of patient care.
