1st session: July 3, 2018 The notion of accident at work at Spanish law. The legal concept and its interpretation by Supreme Court:

General concept.

Presumption. Burden of proof. The accident that happens in time and place of work.

Events considered work-related accidents:

- Accident in itinere

- Act of emergency

Differences between occupational disease and accident at work

Content of Spanish list of occupational disease.

- Group 1. Diseases caused by chemical agents
- Group 2. Diseases caused by physical agents
- Group 3. Biological agents and infectious or parasitic diseases
- Group 4. Respiratory diseases.
- Group 5. Skin diseases
- Group 6. Occupational cancer

Comparison to Occupational disease at International labour standards: ILO Convention 121 and Recommendation 194.

The occupational disease at UE legislation. European schedule of occupational diseases (Recommendation 2003).

4th session: July 6, 2018 Conclusions: Consequences of the distinction between professional contingencies and non occupational contingencies at the Spanish legal system of social security .
