Introduction

The United Nations Convention on the Rights of Persons with Disabilities, concluded in New York on December 13th, 2006 and ratified by Spain in 2007, entered into force on May 3rd, 2008. The purpose of the Convention is to promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities, amongst others, promoting and respecting their inherent dignity (art.1.1). Based on this purpose, article 12.1 reaffirms that persons with disabilities have the right to recognition everywhere as persons before the law.

Law 8/2021, of June 2, *which reforms civil and procedural legislation to support persons with disabilities in the exercise of their legal capacity*, has given a significant impetus to the adaptation of our legal system to the United Nations Convention. The reform of the procedural legislation operated by the Spanish Law 8/2021, has catalysed the approval of the Catalan Decree-Law 19/2021, of August 31, *which adapts the Civil Code of Catalonia to the reform of the procedure of judicial modification of capacity*, a transitory regime, whilst the Catalan legislator culminates a comprehensive and final reform to adapt and align its legal framework to the provisions.

One year after the entry into force of the Spanish Law 8/2021 and the Catalan Decree-Law 19/2021 of the *Generalitat de Catalunya*, this Congress aims to provide a forum to analyse, reflect and debate on the changes and developments from different perspectives of this new set of rules, in which the respect for the legal capacity of persons with disabilities is paramount, as well as to explore the implications of the new paradigm on the provision of support services from a public and subjective right perspective.
