Anyone wishing to submit a paper should send an **abstract** of no more than 600 words by the deadline of 12 June 2020 to jmchaireuel@gmail.com.

This summary must contain the following aspects: name and surname, institution to which it belongs and personal connection, e-mail address, title, main points, brief conclusion and state whether it is chosen for the oral presentation. The languages of the abstract and oral presentations are Catalan, Spanish or English.

The admission of the communications will correspond to the Scientific Committee which will also select 6 communications for oral presentation. The communications admitted and those accepted for oral presentation will be communicated to the interested parties before 19 June 2020.

The accepted abstracts will be posted on the website of the Jean Monnet Chair of EU Environmental Law. The oral presentation will be of a maximum of 5 minutes.

Anyone wishing to submit the **full text of the paper** may do so until **1 September 2020** and it will be published on the website of the Jean Monnet Chair of EU Environmental Law.

The requirements are the following

- Format: maximum length of 10 pages, text in Arial 12, footnotes in Arial 10, 1.5 spacing and top and bottom margins of 2.5 cm
- First page: title, name and surname, position, summary of 120 words maximum and 5 key words maximum (both, at least, in Spanish and English) and a summary that will include all the subdivisions in this order (1, A and a)
- Language: Catalan, Spanish or English
- Bibliography: should be cited according to Harvard Format Citation
