## Academic Background

To enrol in the Summer School, students are expected to have completed at least 60 ECTS (i.e. one full year of studies) in law, political sciences or environmental sciences prior to the commencement of the Summer School programme.

## Language Requirements

The Summer School will be taught in English. Students are expected to have sufficient knowledge of English, at least at B2 level, while C1 level is strongly recommended.

- CV
- Motivation letter up to 1000 words, explaining your interest in attending the Summer School
- Proof of academic background (a statement/certificate issued by your university confirming that you have obtained 60 ECTS credits)
- Proof of language proficiency (at least B2 level of English)



## ECTS and EXAMINATION



*Workload of the programme is equivalent to 4 ECTS*

Regular attendance is required for successful completion of the programme (you will be required to attend at least 85% of all classes within the programme).

The final exam will take place in written form. The grading scale used is Pass/Fail. Each student will receive a Certificate upon the completion of the programme.

## COSTS

The cost of the Summer School 2024 is as follows:

- EUR 600.00
