<b>Purpose of data processing</b>	To oversee management of your participation in the SICUE academic mobility programme.
<b>Lawful basis</b>	Compliance with a mission carried out in the public interest (Organic Law 6/2001, of 21 December, on Universities and Law 1/2003, of 19 February, on Catalan Universities).
<b>Period of data storage</b>	Your data will be stored during the period required to fulfil the purpose for which they were collected and to determine any possible responsibilities deriving therefrom. A permanent record will be kept of the academic agreement, enrolment certificate and record of completed subjects and grades.
<b>Recipients</b>	The data recipients are the University itself, and, where applicable, those responsible for processing the data. If you enrol at the UB, at the end of the placement your home university will receive an academic certificate indicating the grades awarded for each completed subject. Your data will not be disclosed to third parties unless there is a legal obligation to do so.
